Pursuant to Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (general regulation on the protection of data; hereinafter: "GDPR"), we would like to inform you that:

Purposes of data processing

Your personal data will be processed for the purposes of concluding and performing the contractual relationship between the Parties and issuing bookkeeping vouchers, as well as for the purpose of pursuing claims or protecting against claims related to the use of the website and the performance of contractual relations between the Parties, and in cases required by law also for on the basis of consent expressed pursuant to art. 6 sec. 1 letter a) GDPR for the processing of Customer's personal data for marketing purposes.

Data storage time

Your personal data will be processed for the period necessary to achieve the purposes for which the data is processed or until an objection is raised, if the basis for processing is the legitimate interest of the Administrator, or consent is withdrawn, if the basis for processing is consent. Later, the Administrator will store them until any claims are time-barred or until the obligation to store data resulting from legal provisions expires.

Categories of data recipients

Your data may be processed by the Administrator's subcontractors - these are entities whose services the Administrator uses in the performance of its obligations. They will always be processed using appropriate personal data protection and security measures. The administrator does not intend to transfer your personal data to countries outside the European Economic Area or an international organization.

Automated decision making

The administrator will not make decisions about you in an automated manner, including in the form of profiling.

Your rights

You have the right to:

- access to your personal data and the right to request rectification, deletion or limitation of their processing;
- transfer of personal data;
- withdrawal of consent to the processing of personal data to the extent that the basis for the processing of your personal data is consent (withdrawal of consent does not affect the lawfulness of processing, which was applied on the basis of consent before its withdrawal);
- object to the processing of your personal data to the extent that the basis for the processing of your personal data is the premise of the legitimate interest of the Administrator;
- submit a complaint to the supervisory body dealing with the protection of personal data (the President of the Office for Personal Data Protection), if you believe that the processing of data violates the GDPR.

COOKIES

What are cookies?

Cookies are small text-numeric files that are saved by the ICT system in your ICT system (on the computer, telephone or other device from which the website was connected) while browsing the website and allow for identification in the event of reconnection with the website from the device (e.g. computer, telephone) on which they were saved.

The basis for the use of cookies

Cookies are used with your consent. Your consent is expressed through the appropriate settings of the software, in particular the web browser, installed on the telecommunications device used by you to view the content on the website.

Why does the Administrator use cookies?

The main purpose of the Administrator's use of cookies is to manage the website and improve the quality of the content provided by him. Cookies are necessary for the proper display and operation of the website. The administrator may process the data contained in cookies also for the purpose of keeping anonymous statistics and analyzes showing how the website is used, the average duration of the visit to the website. Cookies are not used to identify website users.

What kind of files are used on the website?

The website uses the following types of cookies:

- session cookies which are automatically deleted when the web browser is closed;
- persistent cookies that are stored on the device for a specified period of time; storing these files does not depend on closing the browser;
- own cookies, which are set by the website;
- third party cookies, set by other websites, such as Google Analytics.

How to change cookie settings?

Most browsers accept cookies by default. You can at any time withdraw or change the scope of the previously expressed consent to the use of cookies on the website and delete them from your browser. You can limit or disable cookies in your browser at any time by setting it to block cookies or to warn you before saving a cookie file on the device you are using. In this case, however, it may happen that you will not be able to access some content on the website, and in extreme cases, its correct display may be completely blocked.
